History ST GROW Co.,Ltd.

1973: Yonezo Yamamoto privately began “Yamamoto Sekiyu Ten” as a dealer of Maruzen Petrochemical Co., Ltd.

1997: Tatsuaki Yamamoto established “SANYO OIL Co.,Ltd” in Kirikushi, Etajima-cho, Aki-gun (currently Etajima-city), Hiroshima, and expanded the business to the bunker supply business with barges. The capital fund increased to 10 million yen.

1998: Yamamoto Sekiyu Ten reorganized into private limited company and Tatsuaki Yamamoto became the president with the capital fund of 3 million yen.

April 1999: SANYO OIL Co., Ltd. merged with Yamamoto Oil Limited Company. Its capital fund became 13 million yen.

June 1999: Hiroshima Office of SANYO OIL Co., Ltd. opened.

November 2000: Capital fund increased to 30 million yen.

December 2003: Self Ujina Club opened. (a self-serve gas station)

December 2003: SANYO OIL Co., Ltd. Hiroshima Office moved to the second floor of Self Ujina Club.

July 2011: SANYO OIL Co., Ltd. Tokyo Branch opened.

April 2013: SANYO OIL Co., Ltd. Tokyo Branch moved to 303 room of Shinbashi Plaza Bldg.

Jan 2016: SANYO OIL Co., Ltd. Hiroshima Branch moves to 4th floor of SC Bldg.

Apr 2016: Head Office of SANYO OIL Co., Ltd. moves from Etajima to Ujina(Hiroshima) and Etajima Branch opened.

Apr 2024: SANYO OIL Co., Ltd. Vietnam Hanoi representative office opened.

Apr 2026: Company “HIROSHIMA TSUSAN Co., Ltd.” merged into Company “SANYO OIL Co., Ltd.”

Apr 2026: Change of company name to “ST GROW Co., Ltd.”
